TRUSTS OF FAITH-OUR FINANCIAL FOUNDATION

Philanthropy has been a basic virtue in Indian culture and assistance to needy and deserving widows, orphans, heritage and it has been a part and parcel of one's religious obligation that individuals constituting the society should take care of their poor and needy brothers by donating a part of their earnings and wealth however small it may be. Our holy scriptures clearly and loudly declare that:

त्वदीयवस्तुगोविन्द तुभ्यमेव समर्पये

"O Lord, whatever I possess it is thine gift, with gratitude, I offer the same to you' the scriptures further declare

गौरवं प्राप्यते दानात न तु वित्तस्य संचयात

"One attains honour by charity, not by hoarding of wealth"

Inspired by the above age old heritage and traditions, five eminent and visionary Mohyals, namely Bakshi Ram Dass Chhibber; Bakshi Gokul Chand Chhibber, both residents of Bhera; Mehta Maharaj Krishan Vaid; Chaudhary Ganesh Dass Dutt and Raizada Yogdhyan Bali met at Lahore (now in Pakistan) on 24th May, 1891 and set up an organization known as General Mohyal Sabha ("GMS" for short) for the cause of Mohyals and service to humanity. It is heartening to note that the small sapling planted 125 years ago by the above visionary elders has grown into a massive and magnificent BANYAN TREE under the soothing shade of which we prosper and rejoice. GMS now has a living and positive presence. Its message reaches the Mohyals in India and abroad, quietly and unobtrusively, enriching the lives of people and elevating their minds through the "MOHYAL MITTER", the oldest continuously published magazine of the country, as acknowledged by the Limca Book of Records.

MEN OF VISION

Our founding fathers were indeed visionaries and progressive. The Punjab University was set up in 1882 at Lahore and, as a consequence, a number of colleges and institutions of modern education had sprung up there, the then capital of undivided Punjab. With progressive and robust outlook, our elders rightly and timely thought that the youth of the community, which largely depended on agriculture and inhabited in rural areas, must avail of the golden opportunity by equipping themselves with knowledge, expertise and imbibing them with character and culture, so that, when they inherit the community from the then agro and rural generation, they would manage it in such a way that the community they would be handing down would be a better one.

FOCUS ON EDUCATION AND YOUTH

Our ancestors were not very well well-educated in the modern sense because of their roots in the far flung rural hamlets, but they were wise enough to foresee the coming events and looked towards the welfare and upliftment of younger and emerging generations. With this objective in view, they set up the GMS, an all-pervasive umbrella institution, with the available means at their command to promote welfare, progress and prosperity of general public by providing aid, relief, scholarships, stipends and other

students, children, sick and mentally retarded persons, for

their upliftment. As the first step in above direction a STUDENT'S HOSTEL. MOHYAL known as ASHRAM, was set up at Lahore to accommodate Mohyal boys, who ventured to avail of educational facilities for their career prospects, at a nominal cost.

Our focus on youth and their education/training has grown in large proportion over the years. At present, GMS runs two schools - one at



Dehradun and the other at Haridwar. GMS also runs the well known Mohyal Educational And Research Institute Of Technology i.e. MERIT at Delhi and further provides economic aid to economically weaker students by giving handsome scholarships for school and college education.

TRUSTS

A Trust, according to Section 3 of the INDIAN TRUSTS ACT 1882 "is an obligation annexed to the ownership of property, and arising out of a confidence reposed in and accepted by the owner or declared or accepted by him of another or of another and the owner".

To encourage sound and perpetual financial resources, our ancestors thought upon the idea of setting up Trusts within the larger Trust - a unique invention (modern day Endowment Fund). The idea was to perpetuate the memory of one's glorious ancestors or living ones as also to augment financial resources. Besides providing financial aid to the needy Mohyal students, the most charitable activity, which continues till date was to provide respectable and dignified living to the community's widows. In F.Y. 2015-16 the Sabha gave pension aggregating to Rs. 47,20,892/- to 425 widows. In the budget for F.Y. 2016-17, an amount of Rs.60 lacs has been allotted for relief to widows

CREATION OF FIRST TRUST

The first trust was set up by Bakshi Gokul Chand Chhibber of Bhera in the year 1891 with an initial amount of Rs. 1000/ - (a royal amount in those days), interest from which was used for helping needy Mohyal students. This trust after his death was converted into "GOKUL CHAND CHHIBBER" MEMORIAL EDUCATION FUND". Subsequently, one after the other, many Trusts (Endowments) were set up. The effort was lofty and commendable but, in the initial years, the response was not very encouraging.

EXPONENTIAL GROWN IN THE NUMBER OF TRUSTS / DONATIONS

Till 1978, when Rzd. B. D. Bali came on the firmament and took over as President of GMS, there were only 31

Trusts with aggregate amount of Rs.2,26,634/- compared to which, as on 31.12.2016 there are 2928 Trusts with corpus money of Rs.7,61,96,097/-, which is highly commendable. Today, the credibility of the GMS is at its zenith and donations in the form of Trusts are pouring in, because the community at large feels confident of the management and safety of their money. Besides, after great efforts, the GMS has been recognised as a Charitable Institution under SECTION 12A(a) OF THE INCOME TAX ACT, 1961, which also acts as an encouragement for large donors and the pace of donations has picked up.

TRUSTS & TRUSTEES COMMITTEE FORMED

In February 2011, the President, Rzd. B. D. Bali constituted a "Trust and Trustees Committee" with me as Convenor and at present, the other members of the committee are Sh. Vinod Dutt, Sh. D. V. Mohan, Sh. J.C. Bali, Sh. Sushil K. Chhibber. The committee makes all out efforts to raise / augment the corpus of different funds as also persuades new donors to donate liberally to the Funds.

DIFFERENT KINDS OF TRUSTS

There are two types of trusts – ones opened by the GMS and the others opened by individuals. In the first category fall the Trusts like (i) Education Benevolent Fund Trust (Rs.1,08,43,753/-), (ii) Education Fund Trust (Rs.1,11,88,820/-), (iii) Relief Fund Trust (Rs.39,79,863/), (iv) Widow Fund Trust (Rs.1,29,95,964/-), (v) Sabha Fund Trust (Rs.17,15,638/-), (vi) Mohyal Mitter Fund Trust (Rs.61,40,816/-), (vii) Mohyal Foundation Trust Fund (Rs.3,55,738/-). As on 31.12.2016 there were 1910 langer funds at Haridwar (Rs.2,10,10,000/-) and 492 Langar Funds at Vrindavan (Rs.54,12,000/-)

TRUSTS - A MATTER OF SACRED FAITH

Let me add that all these Trusts are a matter of sacred faith and all possible care has been taken to maintain these and carry out the wishes of the donors in letter and spirit. The way the community has added to the number of Trusts and the Trust Money reflects on the confidence of the community in the working and credibility of the GMS and, further, with the collective confidence in the Members of Trust and Trustees Committee, under the forward looking leadership of Raizada B. D. Bali, the corpuses of these Trusts are being augmented and money added every day by more and more donors. It is noteworthy that even some non Mohyal brothers and sisters have opened Trusts with large donations/corpuses. There is no denying the fact that the most cherished objective of the GMS is to extend financial aid to poor widows, the destitutes; and the handicapped; economically weaker children for their education, as part of the charity work, enshrined in GMS Constitution. The perpetual Trusts opened by our philanthropic brothers and sisters for different purposes, i.e., Widow fund, Relief Fund, Education Fund, Education Benevolent Fund etc. play a significant role in helping the GMS carry out these benevolent and charitable activities. The amounts donated by the individuals for opening the Trusts in the names of their near and dear ones are invested by the GMS in fixed deposits in the public sector banks, which give a return of about 10% p.a., as interest. This interest income is distributed by the GMS to the various beneficiaries, as per the nature of the Trusts. Thus,

the income from Widows Fund Trust goes to help widows; that from Relief Funds Trusts goes for the aid of destitutes and the handicapped; returns from the Education fund Trusts are given as scholarships and/or financial aid to help educate children with limited means. Thus the trusts, besides perpetuating the memories of the donors' near and dear ones, also contribute to the welfare and education of the less fortunate, down-trodden and economically weaker brothers, sisters and children of the community.

As stated above, as on 31st December, 2016 the total Trusts money from the various Trusts maintained by the GMS amounted to Rs.7.62 crores; annual interest from which may amount to about Rs.76 lacs. This together with other donations received by the GMS, help finance its charitable activities, as detailed above. In fact when a donor contributes to the corpus established by him or her, he participates every year in a perpetual YAJNA in the memory of his /her near and dear ones.

GMS GROWING FROM STRENGTH TO STRENGTH

GMS has grown from strength to strength over the last 125 years and is moving steadily towards still greater heights. This is happening solely because of the cumulative contributions of the members of the fraternity worldwide, headed by the visionary and dynamic President, Rzd. B.D. Bali. GMS exists not only in the magnificent buildings it functions from, but in the minds and hearts of its worldspread family. Whatever, we could achieve over the last 125 years is because of unity; integrity; devotion; dedication and team work of all the brothers and sisters. Unity and brotherhood is supreme objective and dire need for progress and prosperity in the fast changing and competitive world and our vibrant community must stand united like a rock. Let us keep up the spirit and vision of our illustrious forefathers with gratitude and fortitude and carry on the torch lit by them 125 years ago. May God almighty guide and help us. I invoke the following invocation from RIG VEDA which we must strive to follow:



GMS 125th STHAPNA DIVAS AND 52nd MOHYAL CONFERENCE

REPORT BY SECRETARY GENERAL GENERAL MOHYAL SABHA (REGD)

Dear Members, Jai Mohyal,

I am honoured to be a part of this August gathering and feel very happy to see members having come from all over the country and abroad. A very warm welcome to each one of you. I will now update and refresh you on the



activities of GMS. The first Mohyal Conference was held at Lahore in 1902. Capt Ganda Singh Datt was the President and Bhai Parmanand Chhibbber from Kariyala was the Secretary. The last Conference (51st), was held at Kulachi Hansraj Model School, Ashok Vihar, Delhi on 7th and 8th Jan 2012, where Lt Gen G L Bakshi. PVSM was the President of the Conference. Today is a very special and historic day, since we have assembled

here to celebrate 125th Sthapna Divas. As you all know GMS was established by a group of dedicated Mohyals at Lahore on 24 May 1891. Bakshi Gokul Chand Chhibber, Bakshi Jog Dhian Bali, Bakshi Ram Dass Chhibber, Bakshi Ganesh Dass Dutt and Rzd Maharaj Krishan Vaid conceived the idea of having a forum for Mohyal Biradri and named it Mohyal Mitter Sabha meaning Friends Association, and its first meeting was held on 20 Sep 1891 at the residence of Mehta Amir Chand Bali and was attended by 29 veteran mohyals. The Sabha was rebaptised as General Mohyal Sabha in 1902 and that name has since stuck. After the traumatic partition of the country in 1947, mohyals got scattered and settled in various parts of the country. GMS first shifted to Amritsar in 1947 and then to Delhi in 1955. During the last four decades, GMS has made tremendous progress and is giving substantial financial assistance to deprived sections of our society.

The saga of the Mohyals through the ages has been one of indomitable courage, devotion, dedication and have played a significant role in the mainstream of the Nation. The sacrifice of Bhai Mati Dass, Bhai Sati Dass, Bhai Praga for the cause of religion is unparalled in the history of the world. The Community has excelled itself in Defence, Police and Administrative services, besides making a mark in Industry, movies and in various other spheres. The main aim of Sthapna Divas is to infuse and imbibe in the coming generation the spirit of selfless service to the cause of weaker section of our community and empowerment of youth and women, who are the future of our country.

We realize that **education is very essential**, to make progress and take the Community forward. Our visionary leader, Rzd B D Bali wishes that no mohyal child should be deprived of education for want of funds. We have given top priority to educate our children and have taken a few steps in this direction.

- Maj K R Bali Mohyal School, Dehradun has been upgraded to class VIII. It has 220 students.
- Play School at Haridwar is being upgraded to class V and the school has been renamed as Mohyal Public School, Haridwar. It has 80 students. A Maruti Van has been purchased for the School.
- Financial help given for education to our needy children has been enhanced. Previously it was given from class VI onwards .It is now being given from class I onwards ie Rs 250/ pm to Rs 3000/ pm, depending on the class in which the child is studying.
- Adopt a Child Scheme, which is also a brain child of our President Rzd B D Bali, is in the final stages of implementation. The scheme envisages provision of comprehensive support to children from financially weaker sections of the community who have also to cope with the unfortunate loss of either one or both the parents.

We are committed to **help the needy widows and destitutes**. Monthly financial assistance is being given to 468 widows and 95 other needy persons. Their pension has been increased from Rs 750/ pm to Rs 1000/ pm wef July 2015. We are also committed to help young widows stand on their feet, by financially supporting them to acquire skills/ professional training to become financially independent. Financial assistance for **medical treatment** is also being given on need to need basis. Financial aid will now be sent through Bank and not by money order from this financial year, and all concerned have been requested to forward their bank details where they wish to receive the financial aid sent by GMS.

The world today is moving at a very fast pace, due to rapid development of technology which is easily accessible. It is a competitive world and one has to excel to find a suitable job placement. We have therefore to motivate our youth to do well academically. Since 2004, a yearly **Pratibhashalee Vidyarthi Samman** function is being held to honour and encourage brilliant students of the community. 13th Pratibhashalee Mohyal Vidyarthee Samman was held at Mohyal Foundation on 4 Dec 2016 for students of class X and Class XII scoring 85 percent and above marks. 78 students were honoured ie 34 students (girls 19, boys 15) of class 12th and 44 students (girls 28, boys 16) of class 10th . 20 students of class 10 scored 10 CGPA and 20 students of class 12 scored 90 percent and above marks. A declamation contest is also held during the awards function to encourage students in public speaking.

Periodic Mohyal **Youth Camps** are being held to empower the youth and encourage them to take part in the activities and development of the community. Youth camp was organized at Byasi, Rishikesh from 4th to 6th Dec 2014, by Mohyal Sabha Dehradun and was totally handled by the youth and was a great success. A Seminar for career guidance and entrepreneurship for youth was

organized by Mohyal Sabha Khanna on 27 Nov 2016. Experts from different fields addressed the youth to guide them to choose a career of their choice and was attended by more than 800 participants .The programme was a grand success and was greatly appreciated. Youth are also encouraged to organize sports activities. Cricket matches have been organized by youth of Mohyal Sabha Khanna, Ludhiana and Faridabad and other Sabhas are in the process of organizing their teams.

In order to encourage and facilitate marriages within the Community, quarterly matrimonial get togethers are held at Mohyal Foundation on last Sunday of each quarter. Yearly **Matrimonial Mela** is also being held since 2006. Details of boys and girls looking for suitable matches are also published every month in Mohyal Mitter under column Matrimonials. 7th Matrimonial Mela was held at Mohyal Foundation on 20 March 2016, and was attended by large number of Parents/ Guardians . Facilities for matching of Horoscopes through computer software as well as traditional Pandit ji were available at the venue.

Presidents and Secretaries meet of the local affiliated Sabhas is held every year, to review policy decisions and progress made, and to ensure close cohesion between GMS and local Sabhas for the welfare of the community. The last Presidents and Secretaries meeting was held on 14 & 15 May 2016, where we had a healthy interaction with the focus on how to take the community forward and help the deprived section of our Biradri.

Annual General Body Meeting (AGM), is held, for which all permanent members and annual members, who are members for three consecutive years are invited to attend. The last AGM was held at Mohyal Foundation on 16 Oct

GMS Managing Committee Meeting is held at 1130 hrs on second Sunday of each month at Mohyal Foundation New Delhi.

Local Sabhas are encouraged to hold Mohyal Mela/ Milan in their areas and are given Shagun of Rs 21,000. Most of the local Sabha's are organising mohyal melas in their areas which helps promote brotherhood and gives an opportunity to members to meet and interact with each

All these platforms have been created to give an opportunity for interaction within the Community with the aim to improve Bhaichara and to bind the Community together.

Mohyal Mitter, the first issue of which was published in Sep 1891, has been recognized as the oldest continuously published magazine in India by Limca Book of Records on 22 Aug 2008 .Our monthly magazine helps the Biradri to remain connected with each other and is unique, since it is based only on the inputs received from members of our Community.

MERIT (Mohyal Educational and Research Institute of Technology) was established in 1999 to impart computer education to mohyal children besides facilitating research in the IT Field. It is accredited to NCVT (National Council for Vocational Training) and is conducting Computer Operator & Programming Assistant (COPA) course since

2008. It is also accredited to IGNOU and JMI for conducting their distance education courses like BCA, MCA, certified course in computer hardware & networking and certified course in information technology. It is also a testing centre for TOEFL & GRE since 2007 and has set up two state of art labs in Sep 2014 .It became an IGNOU exam centre in Dec 2014. At present it has 270 students in IGNOU and 46 students in COPA. As a incentive, mohyal students who are admitted to COPA Course in MERIT will be reimbursed the entire amount of fees paid by them to MERIT and those who get admission in MERIT Study Centre for BCA & MCA Courses of IGNOU and Computer Courses of JMI will be reimbursed 50% of the fees paid by them.

GMS Managing Committee Elections are held every 5 yrs as per the GMS Constitution. The last elections were held on 13 Sep 2015. You will be happy to know that six ladies got elected and are active members of the Managing Committee.

Foundation stone of Mohyal Bhawan at Yamuna Nagar was laid by Rzd B D Bali on 11 Sep 2016 It is another ambitious project of the Community and should benefit all the Mohyal families staying in Yamuna Nagar and the surrounding areas. It will have facilities to open a branch of MERIT and is expected to be completed within two yrs.

National Calamities GMS has always played a pivotal role in the National main stream .A sum of Rs five lacs was donated to the Prime Ministers National Relief Fund on 17 Sep 2014 to help our distressed brothers and sisters of J&K, effected by the unprecedented floods in the State. Relief material was sent to help flood victims of Pithoragarh (Uttarakhand) under our youth team on 12 July 2016.

Credibility and financial stability of GMS continues to show noteworthy progress .We are now financially stable to undertake new projects .The liquid assets of GMS were Rs 22,391/ in 1978, when our revered leader Rzd B D Bali took over as President of GMS. We now have a total of Rs 10,41,42,455,95 out of which Rs 7,61,96,096.83 is Trust money leaving a balance of Rs 2,79,46,359.12 plus fixed assets in the form of our Ashrams at Haridwar, Vrindavan, Goverdan, Inderpuri and Mohyal Foundation .worth crores. No loans have been taken to create these assets .All this has been possible thanks to foresight and excellent financial management of our leader Rzd B D Bali and our great mohyal community who have always come forward and donated generously.

CITATION READ WHILE CONFERRING "MOHYAL RATNA"

ON SHRI SUNIL DUTT (POSTHUMOUSLY)

Shri Sunil Dutt nee Balraj Dutt, son of Dewan Raghunath Dutt and Smt Kulwanti Dutt, was born on 6 June 1929 in village Khurd, District Jhelum. He lost his father, when he was just 5 yrs old. After the trauma of partition, he migrated to Bombay to make a mark for himself as an actor. Initially life was full of struggle. He slept on the pavements and studied under street lights. Determination, strong will power and ambition helped him to realize his dreams. He made his screen debut with Nalini Jaywant starrer Railway Platform, after a stint as radio host. He acted in more than hundred films many of which were box office hits. Mother India, Gumraah, Waqt, Padosan, Munnabhai MBBS to name a few. He also directed and produced several films ie Mujhe Jeene Do, Yaadein, Reshma aur Shera, Dard ka Rishta, which won National and International honours for their artistic content and a human message. Dutt Sahib as he was popularly known, led groups of artists to bring cheer to our Jawans stationed in forward areas after 1962,1965 and 1971 wars .He joined politics in 1984 and was elected to the Lok Sabha from North West Mumbai five times. He served as Sheriff of Mumbai in 1981. He has been honoured with the National Award of Padma Shri and Rajiv Gandhi National Sadhbavna Award for his outstanding contribution to communal harmony, peace and National Integration. He was an astute politician who had never lost an election. He became Union Minister Youth Affairs and Sports, the first mohyal ever to occupy the chair of Cabinet Minister. After the demise of his wife, great actress Nargis in 1981, he established a Trust in her name in Mumbai and United States for treatment of cancer patients. He was Patron of Spastic Society of India, and actively campaigned to combat AIDS.

Dutt Sahib was a devout Mohyal who was deeply interested in the progress made by the community. He was to inaugurate the Mohyal Sewa Sadan at Haridwar on 19 June 2005, but God Almighty willed it otherwise and he left for his heavenly abode on 25 May 2005 due to heart attack, which was a big loss for the Community. Despite his having achieved the pinnacle of success, he was down to earth, extremely humble and a very fine human being.

Dutt Sahib made the entire Mohyal Community very proud by his achievements as an artist and in the field of social service. He was genuine, sincere, devoted and committed to all the causes he undertook. We bow our heads in utmost reverence to one of the greatest Mohyals of our times and in recognition of his meritorious services and bringing lot of glory to the Mohyal Community, the Managing Committee of GMS honours Padma Shri Sunil Dutt posthumously with the highest Award of Mohyal Ratna.

CITATION READ WHILE CONFERRING "MOHYAL RATNA"

ON SHRI ANAND BAKSHI (POSTHUMOUSLY)

Shri Anand Bakshi son of Shri Mohan lal and Smt Sumitra Vaid was born on 21 July 1930 in Rawalpindi. His mother passed away when he was five years old. The family migrated to Delhi after partition and he joined the Indian Army. Bakshi Sahib was fond of writing poetry since his youth ,which he did as a hobby and used his songs and lyrics in local programmes of troops. He was determined to go to Bombay to make a name for himself in writing and singing. Initially he could make no headway and had to struggle a great deal. He stayed with a ticket collector in his one room set at Borivli. In 1958 he got a chance meeting with actor Bhagwan Dada who offered him a job to write the lyrics for his film Bhala Aadmi ,where he wrote four songs .His first song in this film was "Dharti Ke Laal Na Kar Itna Malaal" After writing for few movies he got his big break in 1962 with Mehendi lagi mere haath and a huge breakthrough in 1965 with the super hit film Jab Jab Phool Khile and yet again in 1967 with super hit movie, Milan starring Sunil Dutt . Six hit films within a decade of his entry into films cemented his status as a lyrics writer of immense caliber.

Anand Bakshi was one of the greatest and popular lyricists who wrote simple poetry and memorable lyrics with tunes from films being hummed all over the country. He wrote over 3500 songs for 638 films. Bakshi Sahib was nominated for a Filmfare award almost every year since 1968 and won it three times for films, Apnapan in 1979, Ek Duje Ke Liye in 1982 and Dilwale Dulhaniya Le Jayenge in 1996. He worked with many renowned directors who believed that for a film to be a box office success all it needed was great music and lyrics by Anand Bakshi .Bakshi Sahibs career kept at an all time high until 30 March 2002, when he passed away in Mumbai after a brief illness which was a great loss for the film industry and Mohyal Community.

Bakshi Sahib was a great Mohyal and always looked forward to being with the Community. We recall nostalgically when he was with us and regaled the huge audience with his songs at Talkatora Indoor Stadium during the Centenary celebrations in 1991 and the thunderous ovation accorded to him. Bakshi Sahib made the entire Mohyal Community very proud, by his achievements as an artist who wrote memorable lyrics in many movies. He was very simple and an excellent human being. We bow our heads in utmost reverence to one of the greatest Mohyals of our times and in recognition of his meritorious services and bringing lot of glory to the Mohyal Community, the Managing Committee of GMS honours Shri Anand Bakshi, posthumously with the highest Award of Mohyal Ratna.







differences. He turned the fortune of many people into glorious lives by guidance and advice for technology of plain paper copier.


