PROCEEDINGS OF ANNUAL GENERAL BODY MEETING HELD AT MOHYAL FOUNDATION ON 9 FEB 2020

Annual General Body meeting was held at Mohyal Foundation on 9 Feb 2020. The programme started at 0900 hrs, with Registration wherein members signed their attendance on arrival at the venue. Refreshments were served to the members and it was very heartening to see the members interacting with each other and exchanging pleasantries. Shri Ashok Chhibber, Secretary GMS, requested the members to assemble for the flag hoisting. Lt Gen G L Bakshi, PVSM (Retd) President GMS, unfurled the Mohyal Flag, which was followed by chanting of the Mohyal Prayer by the members, led by Smt Krishan Lata Chhibber, Secretary Matrimonial GMS, and roars of 'Jai Mohyal'. Shri O P Mohan, former Sr Vice President GMS and President 52nd Mohyal Conference and other dignitaries, were escorted to the dais after Deep Prajwalan by Lt Gen G L Bakshi, PVSM (Retd) President GMS and honourable members of GMS.

Lt Col L R Vaid (Retd), Secretary General welcomed the members and said that he was honoured to be part of this August gathering of the Community. He explained the details of the programme of the day, and said that the Business Session will include, Report by the Secretary General, Presentation of Accounts and Passing of the Mandatory Resolutions by Vice President (Legal and Finance) and Points from Members. He said, before we start the Business Session, we will pay homage to all members of our Biradri who have left for their heavenly abode since we last met, by observing two minutes silence and pray to God Almighty to grant them eternal peace. Mohyal Ratna Rzd B D Bali, President GMS, the tallest leader of the Community, left for his heavenly abode, on 12 July 2019, leaving the Community in great grief and profound sorrow. The House stood up and observed two minutes silence as a mark of respect for the departed noble souls.

He then requested, Lt Gen G L Bakshi, PVSM (Retd), President GMS to give the welcome address. Gen Bakshi said that it was his privilege and pleasure to extend a very warm welcome to all mohyal brothers and sisters. He explained that the major purpose for holding AGM by any organization, was, Firstly, Presentation of Accounts and to approve the income and expenditure of the last financial year, approve the budget for the next financial year and pass the mandatory resolutions. Secondly, discussion of any policy issues, Thirdly, to share with the members the functional aspects of the organization for their awareness and knowledge and Points from members can also be taken up for discussion. He said that the organization was doing very well which was primarily due to positive contribution of the members, who all have a common aim to take the community forward. Gen Bakshi drew the attention of the members to the Mohyal Prayer. He said that, we as a Community have a very profound and meaningful Prayer which we recite with pleasure and pride, before every Community activity/event and we must follow it in letter and spirit. He emphasized on two aspects of the prayer ie Doosron ki baaton ko dhairye aur shantipurvak sune and Apni baatien madhur shabdon mein kahen. He said that he was of the view that, all members have in their mind, nothing but the very best for the Community, in whatever views they propound and whatever actions they take. However, unwittingly, sometimes they end up hurting the very

community they wish to do good to. However justified (g) they might feel about their views, decisions can only be taken based on majority view. Therefore do not be oversensitive and feel aggrieved to the extent that you go to Court. By so doing, you greatly harm the organization that is indeed yours, since it puts a financial liability on GMS, which reduces funds availability for welfare. Gen Bakshi said that he was sharing with the members, that there is no intention of tinkering with our Constitution in the near future and requested the members not to talk about the Constitution in this AGM. He then appealed to the members, to come forward and donate liberally for the rooms to be constructed at Mohyal Ashram Haridwar. Room donation has been kept at 3 Lacs, even though each room will now cost much more.

Lt Col L R Vaid (Retd), Secretary General GMS, read out his report, which gave details of the activities of the GMS since the last AGM which was held on 10 March 2019. The report is printed elsewhere in this issue of Mohyal Mitter.

Bakshi B L Chhibber IRS (Retd), Vice President GMS (Finance & Legal), presented the audited accounts for the financial year 2018-2019 and the Budget proposals for the financial year 2020-21. After giving item wise explanations in the audited accounts and the budget proposals, he put five resolutions to vote, which were passed unanimously. The report is printed elsewhere in this issue of Mohyal Mitter.

Members were invited on the dias, to share their thoughts and give their suggestions concerning GMS. 16 members spoke and the following points emerged.

- (a) A statue of late Rzd B D Bali, President of GMS, be installed at a appropriate place, as a mark of respect to him, for rendering selfless service to the Community for four decades.
- (b) Free life membership should be given as an incentive, to five topper students honoured at Pratibhashalee Mohyal Vidyarthee Samman which is organized by GMS every year.
- (c) To start a membership drive and increase the membership of GMS, the apex body of the Community.
- (d) Funds can be saved and better utilized if the elections of the GMS Managing Committee are conducted by show of hands, instead of through casting of ballots.
- (e) Remain united as a family and promote brotherhood.
- (f) On death of a member, the membership should be transferred to the spouse.

- (g) Land occupied by Mohyal Education Society which was in RK Puram, should be taken back, being prime land.
- (h) Members should have spirit of dedication towards the organization, maintain self discipline and not waste time of others.
- (i) Increase the education grant given for education of mohyal students.
- (j) Members appreciated the positive work being done by the GMS Managing Committee.
- (k) Increase contact with the mohyal brothers and sisters, by organising door to door contact programme.
- Members shared, steps being taken by their Sabhas towards youth and women empowerment.
- (m) Increase the Shagun given to the Sabhas for organising Mohyal Milan to Rs. 31,000/-.

In his concluding remarks, Lt Gen G L Bakshi, PVSM, (Retd) President GMS said that points raised by members will be duly considered. He also said that, may be there is a case for widows becoming more a family responsibility, the younger ones be encouraged to remarry/settle down by acquiring professional skills, and greater weightage be given to allotment of funds for education of childen. Shri Vinod Dutt, Vice President GMS, thanked members for sharing his grief and standing with him, when he lost his wife, Sangeeta Dutt on 24 Nov 2019. He said that GMS is our mother body and we should all work together and strengthen it and explore avenues to make our Institutions self sustainable. Shri P K Datta, Sr Vice President GMS, said that our Community was our biggest asset and by exchange of views we can develop our great community and ensure its growth and progress. He said that it was a very good meeting and we should all work to make our organization strong. The meeting ended with a vote of thanks by Shri P K Datta, which was followed by Shanti Path, Group photo and sumptuous Lunch.



ANNUAL GENERAL BODY MEETING – 9 FEB 2020 REPORT BY SECRETARY GENERAL GMS

My Dear Brothers and Sisters, JAI MOHYAL

It gives me great pleasure to extend a very warm welcome to each one of you. We look forward to a healthy interaction, on how to reach the less privileged members of our Community and help them in every possible way. We should all continue to think, what we can do to further integrate our great community and to take it forward. I will now update and refresh you on the events which have taken place since the last AGM, which was held at Mohyal Foundation New Delhi on 10 March 2019, details of which have been published in our monthly magazine, Mohyal Mitter April 2019 issue. As you know, Mohyal Mitter was accepted by the Limca Book of Records on 22 Aug 2008, as the oldest running magazine published since 1891.



Education is essential to make progress and to take the Community forward. We are committed to ensure that no Mohyal child is deprived of education for want of funds. I am pleased to inform you, that our Schools at Dehradun and Haridwar are running smoothly. Major K R Bali Mohyal Public School at Dehradun, which was started in 2007, has been upgraded up to class 8 and has 277 students. Mohyal Public School at Haridwar, which was started in 2012, has been upgraded up to class 5 and has 144 students. Financial help is being given for education to 76 needy students ie Rs 250/- pm to Rs 3000/- pm depending on the class in which the child is studying. The financial aid is being sent twice a year ie from Apr to Sep and from Oct to Mar.

It is a very competitive world and our children have to excel academically to find a suitable job placement. We have therefore to motivate our children to excel in their studies so that they can get admissions in the subjects and colleges of their choice. Keeping this in view, Pratibhashalee Mohyal Vidyarthee Samman function is organized every year, to honour and encourage brilliant mohyal students. 17th Pratibhashalee Mohyal Vidyarthee Samman function, was held on 8 Sep 2019 for students of class X and class XII scoring 85 percent and above marks. 60 students were honouredie 23 students of class XII, out of which 11 were girl students, and 37 students of class X, out of which 18 were girl students. 10 students of class XII scored over 90 percent marks, out of which 5 were girl students and 29 students of class X scored over 90 percent marks, out of which 13 were girl students. A declamation contest was also held during the awards function, to encourage the students in public speaking.

The youth are being encouraged to take part in the community affairs. It has been heartening, to see our youth actively involved in organizing and conducting the Mohyal Milans organized by their Sabhas. Local Sabha's have been organizing cricket matches and sports activity involving the youth and have also been honouring their meritorious students. A youth activity is planned to be held during the vacation period, after the exams of the students are over.

We are committed to help the needy widows and the underprivileged members of the community. Financial assistance of Rs 1000/- pm has been given to 473 widows and 91 underprivileged persons. Financial assistance is being sent directly to the bank accounts of the individuals since June 2017. We are keen to help the unfortunate young widows, stand on their feet by financially supporting them to acquire skills/professional training to become financially independent. Financial assistance for medical treatment, is also being given to the needy mohyal son, need to need basis.

In order to encourage and facilitate marriages within the community, quarterly matrimonial get togethers, are held at Mohyal Foundation on last Sunday of each quarter, which is attended by parents/

guardians of eligible boys and girls. Particulars of boys and girls for matrimonial alliance are being published in the Mohyal Mitter every month.

Presidents and Secretaries meet of local affiliated Sabhas was held on 17 Nov 2019, where we had a healthy interaction, with the focus on how to take the community forward. Local Sabhas are encouraged to hold Mohyal Milans in their areas and are given a Shagun of Rs 21000/-. The aim is to promote brotherhood by giving an opportunity to the Biradri to interact with each other. Sabhas are requested to observe austerity and avoid wasteful expenditure on mementos, shawls, flower bouquets etc. The money saved should be utilized on welfare of the children.

Foundation stone of Mohyal Bhawan at Yamuna Nagar was laid on 11 Sep 2016. Construction started on 9 June 2017 and is now near completion and we hope to dedicate the same to the community very soon. The proposal of adding third floor in A and B blocks of Mohyal Ashram Haridwar is in hand, and God willing construction will start this year. Members are requested to come forward and donate whole heartedly for these prestigious projects of the community. Property, B 64 Defence Colony Meerut, which was donated to GMS by Major Amar Nath Chhibber, has been given on rent for Rs 16,000/per month wef April 2019.

MERIT was established in Oct 1999 by GMS, with the objective of making a presence in higher education specially in the field of IT (Information Technology). It has been accredited to the National Council for Vocational Training for conducting Computer Operator & Programming Assistant course (COPA) since 2008. It is also a Programme Study Centre of IGNOU for conducting their distance education courses in BCA/MCA/IT Skill and Info Security /PG Geo Informatics andapplied Statics. It has also been a testing centre for Test of English as a foreign language (TOEFL since 2007) and Graduate Record Examination (GRE since 2013) and has set up two State of Art Computer Lab in 2014, for conducting these tests. It became an IGNOU Exam Centre in 2014 for conducting exams for all the programmes offered by IGNOU. As an incentive, no fees are charged from the Mohyal students admitted to COPA course in MERIT. Mohyal students, who get admission in MERIT study Centre for BCA & MCA courses of IGNOU, are reimbursed 50% of the fees. It is now launching courses on Big Data Analytics and Cyber Security and short term job oriented courses.

Credibility and financial stability of GMS continues to be high and we have fixed assets in the form of Ashrams/Bhawans at Haridwar, Vrindavan, Goverdhan, Inderpuri, Mohyal Foundation and Yamuna Nagar. No loans have been taken to create these assets which belong to the Community. We want our Ashrams and Institutions to be self sustaining so that the available funds can be used, more for welfare activities. Portion of phase 1 of Mohyal Foundation has been given on rent for Rs Ten lacs per month, less 10% given to DDA, wef 16 Jan 2019, which is a major source of our income and is used to fund the welfare projects of the community.

The Community suffered a grievous loss, when we lost Mohyal Ratna, Rzd B D Bali, President GMS, the tallest leader of the Community, on 12 July 2019. He nurtured the Community and brought it to the present glory and will always be remembered with great respect and gratitude, for being a great human being and for the selfless services rendered to the Community for four decades. It is now the responsibility of each one of us, to maintain our assets created by him and his dedicated team of mohyal brothers and sisters, and work together hand in hand, and take the community forward.

ANNUAL GENERAL BODY MEETING 09 FEBRUARY 2020 Report by the Vice President GMS (Legal & Finance) Accounts and Budget Proposals

Bakshi B.L. Chhibber IRS (Retd.) Vice President, Legal and Finance after invoking the blessings of

Lord Parshuram ji and Saptrish is submitted, that the GMS was founded at Lahore on 24 May 1891 by our illustrious forefathers and it has completed 129 years of its glorious existence and service to the community and humanity. It is a proud moment for all present in this august meeting. Thereafter, Shri. Chhibber presented the audited accounts i.e. Income and Expenditure Statement and Balance Sheet for the Financial Year 2018-19 ended on 31.03.2019, copies of which were sent to all the members along with the notice of meeting sent by courier service on 06.01.2020. Budget proposals for the Financial Year 2020-21 were circulated to all the members present in the meeting in advance.

Shri Chhibber stated that GMS is registered under the Indian Societies Act, 1860, and under Section 12AA of Income Tax Act, 1961 as "charitable" institution. Accordingly, regular books of accounts are being maintained as per the requirements of the legal provisions of the above noted two Acts and were audited by the Chartered Accountants M/s. H.S. Ahuia & Company who after thorough



by the Chartered Accountants M/s. H.S. Ahuja & Company who after thorough examination and scrutiny have certified as follows:

"We have examined the balance sheet of GENERAL MOHYAL SABHA (REGD) AAATG5350R [name and PAN of the trust or institution] as at 31.03.2019 and the Profit and loss account for the year ended on that date which are in agreement with the books of account maintained by the said trust or institution.

We have obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of the audit. In our opinion, proper books of account have been kept by the head office and the branches of the above-named trust visited by us so far as appears from our examination of the books, and proper Returns adequate for the purposes of audit have been received from branches not visited by us subject to the comments given below.

In our opinion and to the best of our information, and according to explanations given to us, the said accounts give a true and fair view:-

- (a) in case of the balance sheet of the state of affairs of the above-named trust as at 31.03.2019
- (b) in the case of the profit and loss account, of the profit or loss of its accounting year ending on 31.03.2019"

Explaining the salient features of the accounts, he submitted that main source of income is from rent which during the year was Rs. 23,75,500/- as against NIL income from this source in the preceding year. It was because the part of the Mohyal Foundation building remained vacant for lack of suitable tenant in the preceding two years. It could be let out only from 16th January 2019 to 31st March 2019 i.e. for a period of two and half months at monthly rent of Rs. 10 Lakhs. Now the building is duly rented out and in the budget for the Financial Year 2020-21, rental income has been estimated at Rs. 1,20,00,000/-. Besides the Meerut property has been let out and rental income from this property situated in Defence Colony, Meerut has been estimated at Rs. 1,92,000/- for the Financial Year 2020-21. Income from general donations was to the tune of Rs.1,82,55,943/- as against Rs.1,31,28,149/- of the corresponding previous year – an increase of Rs. 51,27,794/-. Income from bank deposits was to the tune of Rs. 44,79,511/-, mainly on the corpus fund of the trusts. As on 31.03.2019 the corpus amount stood at Rs. 9,44,58,236/- as against Rs. 9,12,03,016/- of the preceding year – an increase of Rs. 32,55,220/-. Number of trusts is as follows:

During the year under review income from tuition fees was to the tune of Rs. 56,71,123/- as against Rs. 54,66,708/- of the preceding year. Contribution / Honorarium form Indira Gandhi Open University was to the tune of Rs.17,26,017/- as against Rs. 14,68,264/- in the preceding year—an increase of Rs. 2,57,753/ during the year under review. Fees from MERIT was Rs. 4,05,777/- and from TOEFL (Test of English as foreign language) was Rs.19,43,578/-.

After giving analysis of the main sources of income, Shri. Chhibber analyzed the salient features of expenditure during the year. Pension to widows was given to the tune of Rs. 46,16,950/- to 462 widows. Relief and welfare to Needy and Destitutes was to the tune of Rs.12,03,750/- to 90 beneficiaries. Relief and welfare by way of free Langar at the Ashrams was to the tune of Rs. 39,43,695/-. Financial aid for education was to the tune of Rs. 6,74,800/- to 81 beneficiaries. Expenditure on staff welfare stood at Rs. 1,98,674/-. Further an amount of Rs. 1,06,09,851/- was spent on account of establishment - a sum of Rs. 12,26,491/- was spent on Building and Repair and Maintenance and Rs. 46,41,110/- was spent on property tax. A sum of Rs. 1,77,120/ was spent on insurance of buildings; a sum of Rs. 1,95,000/- was spent towards lease and ground rent of Mohyal Foundation building.

Coming to the budget proposals, Shri. Chhibber submitted that a sum of Rs.57,80,000/- has been earmarked for widows welfare; Rs.12,00,000/- has been earmarked for relief fund. A sum of Rs.57,05,000/- for MERIT; a sum of Rs. 80,00,000/- for Ashram Fund at Haridwar; a sum of Rs. 48,00,000/- for Vrindavan Ashram; provisions of Rs. 20,00,000/- Yamuna Nagar Community Hall Fund. Similarly adequate funds have been provided under different heads in the detailed budget. The budget estimates for the Financial Year 2020-21 show a surplus of Rs. 46,09,524/ (Receipts Rs. 5,52,24,524/- expenditure Rs. 5,06,15,000/-).

In conclusion he reiterated that the accounts of the GMS are being maintained most meticulously both in traditional form by Double Entry Book Keeping as well as through computer and every paisa of money received and expenses incurred have been duly accounted for as per the statutory provisions and under the quidance of expert chartered accountants. He reminded the August Audience that the small sapling planted by our visionary ancestors one hundred twenty nine years ago in 1891 has grown into a Big Banyan Tree-healthy and strong providing soothing shade under which the members of the community have right to rejoice. He called upon the members to donate generously and augment the various funds of the Sabha by opening Trusts in the memory of their ancestors and dear and near ones. The total amount of the Trusts opened by the individuals and Langar funds Trusts exceed Rupees 9 crores and 44 lakhs. Only interest is used for activities of the GMS keeping the capital intact. He further added that these Trusts are a matter of sacred faith and all possible care has been taken to maintain these and carry out the wishes of the donors in letter and spirit. The way the Community has added to the number of Trusts and the Trust Money reflects the confidence of the Community in the working and credibility of the GMS under the visionary, dedicated and devoted leadership of our late illustrious President Raizada B.D. Bali and his dedicated team and all present in this meeting. He further added that Trusts are being augmented and money added every day by more and more donors. Trust money is sacred, eternal and perpetual; the donations are put in fixed deposits and only interest accrued thereon is utilized for the purpose for which the Trust is created. He exhorted the Audience to be proud of the legacy of our illustrious and farsighted forefathers and count on their blessings and put concerted efforts to carry on the rich legacy for further generations to come. He concluded by invoking the following shloka from our holy scriptures:

Resolved, that the general body of the General Mohyal Sabha (Regd.), in its meeting held on 9th February 2020 at Mohyal Foundation, New Delhi, appreciates and approves the report for the period 2018-2019, submitted by the Secretary General of the Sabha.

The resolution was proposed by Shri Ramesh Datta and seconded by Shri S S Mohan and the House approved it unanimously.

RESOLUTION – IV

Resolved, that M/s. H.S. Ahuja & Company, Chartered Accountants, H-61, Gobind Mansion, Connaught Circus, New Delhi-110001, are hereby appointed as auditors of the General Mohyal Sabha to hold office from the conclusion of this General Body Meeting until the conclusion of the next General Body Meeting of the Society on such remunerations and terms and conditions as may be fixed and approved by the Managing Committee of the GMS.

The resolution was proposed by Shri J C Bali and seconded by Shri Gulshan Vaid and the House approved it unanimously.

- 2. Bookings can also be done on telephone and at the counter in the respective Ashrams.
- Rooms can be booked on twin sharing basis (2 adults and a child below 12 yrs) for a maximum of 3 days. Check in / Check out time is 12 noon.
- 4. Room bookings can be done after payment of 50% of room donation. The amount will be forfeited if booking is not cancelled at least 48 hrs before booking date. The donation can be kept in suspense for two months for future booking if cancellation is done 48 hrs in advance.
- 5. Bulk booking (more than 3 rooms) can be done only after prior written approval of GMS.
- Room donors can donate 25% of the standard room rates (Non Mohyal rates) or pay the prevalent room donation as per their discretion.




गुड-नाईट (हास्य-कविता)


